Here you will find guidelines on how to cite documents used in a text. 1-Citing a work with individual authors - For the first mention of an author in your text, use the full name. - After the first mention, simply include the author's last name before the page number between parentheses. (see the following example)

How to cite a document in MLA Style?

Begin your citation with the name of the author. Your full citation begins with the last name of the individual author of the document, followed by their first initial. Separate multiple author's names with commas, using an ampersand (&) before the last author's name.

To add a citation to your document, you first add the source that you used. Add a new citation and source to a document. On the References tab, in the Citations & Bibliography group, click the arrow next to Style and click the style that you want to use for the citation and source. For example, social sciences documents usually use the MLA or APA styles for citations and sources.

Add citations in a Word document - Word

For example, if the source you wish to cite is a PDF of a newspaper article, cite the source as you would a newspaper. Then, depending on the citation style you are using, you can add a short note to the citation that indicates that the source was in PDF format.

If a personal author or a corporate author (e.g. government agency or organization) cannot be identified, start the citation with the title of the document. Title of Document: Subtitle if Given . Edition if given and is not first edition, Name of Government Department, Agency or Committee, Publication Date, URL.

• Documents published in electronic formats are cited in the same way as print documents. If the electronic document has an author and date of publication, cite these in the text. If the electronic document has an author and date of publication, cite these in the text.

Double space the entire document, even between the title of the page and the first citation. Citations are listed in alphabetical order by the first word in the citation (usually the last name of the author or the first word in the title if the citation does not include the author's name.

Include as much descriptive information as necessary to help readers understand the type and nature of the source you are citing. If the author's name is the same as the uploader, only cite the author once. If the author is different from the uploader, cite the author's name before the title.

To cite sources, first determine whether you're using in-text, MLA, Chicago, APA, or Turabian citation, since each style has different rules. Then, while you're writing your paper, be sure to put an appropriate reference next to each cited statement. APA Citation Style does not have a separate category for government publications. According to APA, government documents can be considered Books, Technical/Research Reports or Brochures. Helpful Tips: Treat a government document as a book, report, or brochure. If a person is named on the title page, use her or him as author.

Legal documents such as laws or treaties require a specific order for their citations. Begin the citation with the name of the country's government that produced it. Follow this with the name of the agency within that government.
